MVO XTRA contains a distinct, high-quality combination of methylated soybean oil and organosilicone surfactant. The oil is a superior penetrant that aids certain pesticides in moving through the waxy cutcle of plants and leaves for greater efficiency. In addition, the organosilicone surfactant increases spreading and wetting of the applied solution so that the active moves to and through the plant quickly.

Use MVO XTRA wherever a label calls for an MSO or MVO and allows or does not exclude the use of an organosilicone.

Preferably, add MVO XTRA last before the final addition of water.
